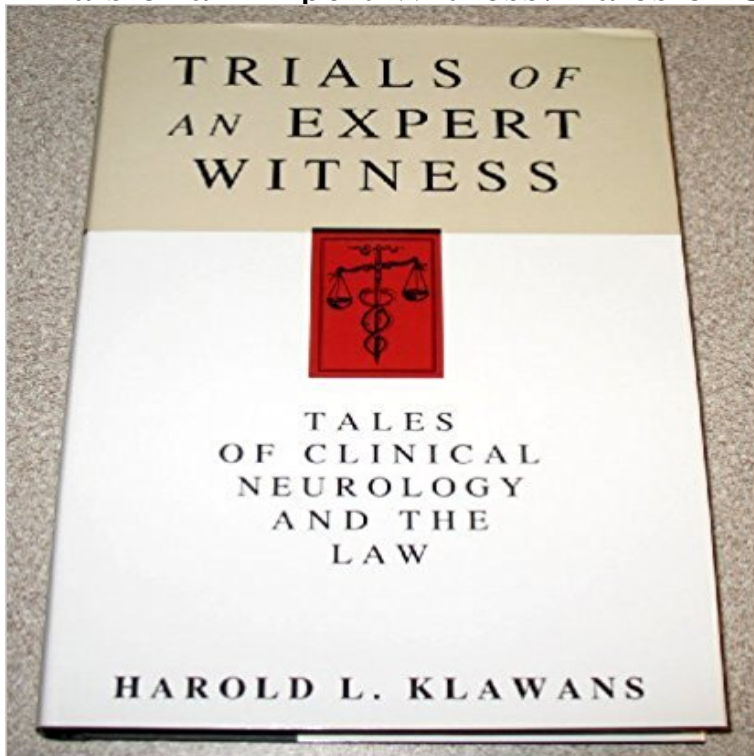


## Trials of an Expert Witness: Tales of Clinical Neurology and the Law
