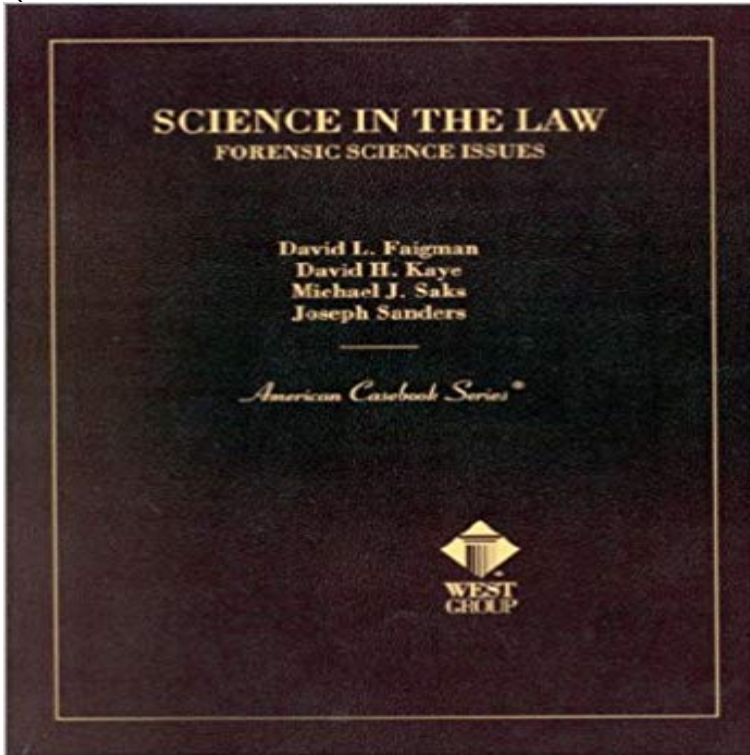


Science in the Law: Forensic Science Issues (American Casebook Series) (American Casebook Series and Other Coursebooks)
